**APPROVAL OF MINUTES**

Moved by Mrs. White, seconded by Mrs. Carr that the minutes of the meeting held June 14, 2017 be approved. Carried. Ayes: Trace, White, Carr. Nays: None.

**QUIT-CLAIM REQUEST**

A written request from Donna Herrington May to sell one grave back to the village was reviewed and discussed. Moved by Mrs. White, seconded by Mrs. Carr to approve the quit-claim request upon receiving a signed and notarized affidavit stating that she is the only surviving relative of the family. Carried. **NON-RESIDENT REQUEST TO PURCHASE GRAVES**

A written request from James McMonagle (Russell Township resident) to purchase two in-ground graves was reviewed and discussed. Because of the inability to expand, a motion was placed on the floor by Mr. Trace and it was seconded by Mrs. Carr to deny the request to purchase in-ground graves. At this time they are limited to Chagrin Falls Village residents only. An alternative is to purchase a niche in the columbarium. Carried. Ayes: Trace, White, Carr. Nays: None.

**PROPOSED COMMEMORATIVE PLAQUE**

This was tabled due to the fact that the commission is not happy with the \$50,000 "restoration" of the Civil War Memorial. It appears that all they did was re-level the sandstone and re-grout it. It doesn't improve the condition or appearance of the monument. They will have to review the contract with ICA - Art Conservation to see what was actually supposed to be done.

**TURF MAINTENANCE**

The commission is still not happy with the work that Augustine Landscaping is doing in Evergreen Hill Cemetery. They are scalping the grass, they are not weed whipping in some areas, and there are weeds in some of the bed areas.

**MISCELLANEOUS**

Tank Landscaping has not yet repaired the ruts in the grass, to the left of the maintenance building, that have been there since Blossom Time and they have not repaired the gutter that was damaged.

The meeting adjourned at 10:14 a.m.
