3. Develop the area south of Sections 45 & 46;
4. Move the cemetery garage/office to the south and develop that land.

There was discussion on converting the mausoleum into a columbarium.

MISCELLANEOUS

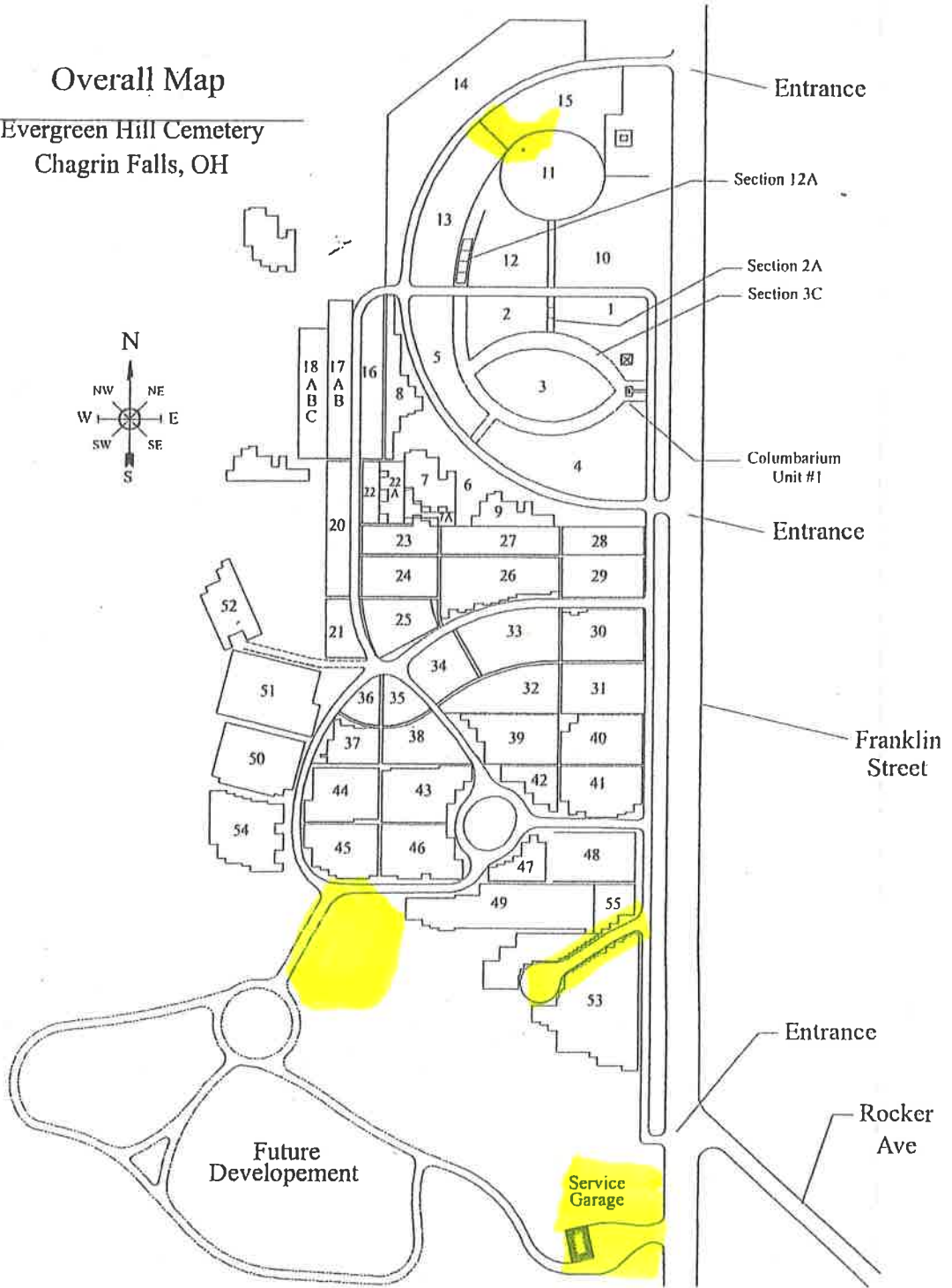
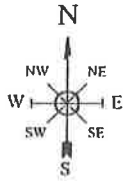
