because restrictions force people out.

Ms. Rogoff said this is for a very large piece of play equipment; 5' x 10' and 6' high is a large piece of play equipment. It isn't really any different from somebody having a garden shed or some sort of storage shed in their back yard that would be treated the same. It has to be a large piece of play equipment before it is regulated.

Mr. Himes said when it reaches that size it triggers the setback requirements. The first sentence says play equipment shall be located only in side and rear yards so that regulates all play equipment. Then it goes on to regulate the larger ones with the setbacks.
