This is an overestimate of the amount of expenditures that we would have in the first quarter of 2018. The breakouts that you see in Section 1 are very round numbers that pad quite a bit what we'd ever need to spend in that first quarter to give us the ability to appropriate anything beneath that amount.

Mr. Himes said this is the same contract that we had last year. The increase is about 2% of the base rate and that is the rate that the village pays per trip. It is going from \$24.75 to \$25.25. Over the entire year of 2017 we paid a total of about \$12,000 so we are averaging about \$1,000 per month. This increase should cost about \$250.00 for the year assuming that we have trips on about the same pace.

Mr. Himes said as I am sure everyone recalls vividly when we discussed the Cleveland water contract, our analysis showed that when that reduction in minimum take fully kicks in our ground water supply from the wells will become marginal so we put out a request for qualifications for a hydro-geologist to help us with analyzing the existing water system and potentially augmenting our supply so that we are able to take advantage of the reduction in the Cleveland water contract.

Mr. Himes said you have probably noticed that we paved the Riverside Park parking lot, the alley behind the hardware store, and along side the old Rick's Café location. They are on private property and the private property owners are paying for it.
