Mayor Tomko recognized that this is the last Council meeting for Council members Berkobein, Lutz, Mitchell, and Chief Administrative Officer Himes. Mayor Tomko and Mr. Maersch thanked each one of them for their leadership and service.

Mayor Tomko reported that the savings by regionalizing and then bringing in new members to the Chagrin Valley Dispatch has reduced our capital cost this year by just under \$28,000 and a projected savings for next year is just a little under \$7,000 which would bring the four year savings to just under \$81,000. The benefits and cost savings have been very material to the village. The service and the equipment that is provided is something that we simply couldn't have afforded. Mrs. DeBernardo said this is a 3% cost of living increase proposed to us by the Mayor. The Administration and Compensation Committee found that it was in line with the 2% to 3% increases that are being given throughout the Chagrin Valley and other municipalities. It is also in line with Social Security going up by 2% and with the Consumer Price Index. In 2017 a 3% increase is the average cost of living increase. Our committee recommended that Council approves this 3% increase for the year 2018. I would also like to say that we need to amend the first page of this ordinance because the position schedule only lists one traffic officer and it needs to be changed to 2 part-time traffic officers before we vote. Mrs. Lutz said you might want to point out that the employees took far less than the cost of living in the few years previously. Mrs. DeBernardo said for the last five years, in a review of what the increases have been, we traditionally have given between a zero% increase (in 2015) to a 1.5% increase, which are under the standard cost of living increases for the nation. This is a long overdue normal rate of increase for our employees.

We can not under-appropriate. Since we don't know in any one case there might be some last minute spending required most of these numbers are inflated and actual numbers at yearend will be lower. He said on page #2 there is a typo under the police pension fund and the \$88,000 should be \$87,000.

Now we are going to have a hydrogeologist actually evaluate how much water we can pump from the two wells as phase 1 and phase 2 is looking for other potential sources of ground water so that we can become even less dependent on Cleveland City Water. It makes very good financial sense for us to become more autonomous with our water as opposed to buying it from Cleveland.
