REPORT OF THE ENGINEER

Mr. Lannon reported that Walters Road is open, the road program is 90% complete, and the Greenbrier construction, the main line pipe work, is about 75% complete.

REPORT OF THE POLICE CHIEF

Chief Dacek reported that they are running radar on Walters Road four times a day and they rolled out a soft launch of the Park Mobile System.

Anne deConingh mentioned that the flowers that were planted in the zig zag walkway by the library and the plantings at the Ben King Memorial Arboretum were paid for by Kathy Watterson. She said the Beautification Committee is planning to do a cleanup of the garden beds and urns on Monday, October 22, 2018 and Wednesday, October 24, 2018.

MISCELLANEOUS

Mr. Newell said I would like to look again at the traffic sequencing for the pedestrian crossings. I don't know that the three to five second head start for pedestrians is making the situation any safer. It seems that the light sequencing seems to be a little awkward. Mrs. DeBernardo said they need to have a discussion to see if everything is working as we intended it to work.

Ms. Rogoff said there is an indication on Facebook that the village is switching all the street signs to large white signs. Mr. Jamieson said we have started replacing the signs and they are slightly larger. Ms. Rogoff said she is disappointed to find that we are not going to have the nice green signs like we have from the beautification project ten years ago and there has been no input from the Parks Commission or Council to switch to larger white signs. Mr. Jamieson said most of the signs that are being replaced are thirty plus years old that were not a part of the Streetscape Project. The Streetscape signs are mostly black and white in the downtown district.

Mr. Newell said the state passed new regulations for the signs to be more visible and this was something that we knew was coming and it has been discussed. The former Chief Administrative Officer brought it up quite a few times.
