

**AN ORDINANCE  
AMENDING SECTION 111.01 OF THE CODIFIED  
ORDINANCES OF THE VILLAGE OF CHAGRIN FALLS AND  
DECLARING AN EMERGENCY.**

WHEREAS, existing Codified Ordinance Section 111.01 requires that regular meetings of Council shall be held at 8:00 P.M. on the second and fourth Mondays of each and every calendar month; and

WHEREAS, the Council has determined that the time of the meeting shall be flexible and determined by Council based on seasonal factors, conflicts in schedules, and other relevant criteria.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, CUYAHOGA COUNTY, STATE OF OHIO:**

SECTION 1. That Section 111.01 of the Codified Ordinances of the Village is hereby amended to read in its entirety as follows:

**111.01 REGUALR MEETINGS.**

Regular meetings of Council shall be held in the Village Hall at such time as established by Council, on the second and fourth Mondays of each and every calendar month, except that Council may cancel one of the monthly meetings, in its discretion. In the event there is no business to be considered by Council at the next regular meeting, the President of Council, upon notice to all other members of Council, the Mayor, Clerk of Council, Law Director and the Chief Administrative Officer, may cancel such meeting. Cancellation by the Council President shall be made no later than 4:00 P.M. on the Friday prior to the regularly scheduled Council meeting if cancellation was not declared at the last regular Council meeting.

SECTION 2. That existing Section 111.01 of the Codified Ordinances of the Village of Chagrin Falls, the full text of which follows is hereby repealed:

**111.01 REGULAR MEETINGS.**

Regular meetings of Council shall be held in the Village Hall at 8:00 p.m. on the second and fourth Mondays of each and every calendar month.

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

**ORDINANCE NO. 2016-20**

SECTION 4. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 5. That this Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of the inhabitants of the Village and for the further reason that this Ordinance must be immediately effective for Council to reschedule Council Meetings and to provide adequate notice of future meetings to the public, the media and to those who request a notice of meetings; wherefore provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Ordinance shall be in full force and effect from and immediately upon its passage by this Council and approval by the Mayor; otherwise, it shall take effect and be in force after the earliest period allowed by law.
