

**AN ORDINANCE
AMENDING CODIFIED ORDINANCE SECTION 133.03(d) TO
PLACE JURISDICTION OF PUBLIC CEMETERY
CONSTRUCTION, IMPROVEMENT, REPAIR AND
MAINTENANCE UNDER THE AUTHORITY OF THE CHIEF
ADMINISTRATIVE OFFICER AS REQUIRED BY THE
CHARTER OF THE VILLAGE OF CHAGRIN FALLS.**

WHEREAS, Codified Ordinance Section 133.03(d) currently provides that responsibility for construction, improvement, repair and maintenance of public cemeteries is to remain under the jurisdiction of the Board of Cemetery Trustees; and

WHEREAS, the Charter of the Village of Chagrin Falls was amended by vote of the electors of the Village on November 8, 2016 in Section VI-2(d) to provide that the Chief Administrative Officer is responsible for public cemetery construction, improvement, repair and maintenance, and the Charter was amended to eliminate the Board of Cemetery Trustees, and therefore Codified Ordinance Section 133.03(d) needs to be revised to be consistent with the Charter.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, STATE OF OHIO:

SECTION 1. Codified Ordinance Section 133.03(d) is hereby amended in its entirety to read as follows:

(d) Be responsible for the construction, improvement, repair and maintenance of all public streets and alleys, public buildings, drains, ditches, storm sewer facilities, parks, playgrounds, public cemeteries, and public places.

That existing Codified Ordinance Section 133.03(d), the full text of which follows is hereby repealed:

(d) Be responsible for the construction, improvement, repair and maintenance of all public streets and alleys, public buildings, drains, ditches, storm sewer facilities, parks, playgrounds and public places, except that public cemeteries shall remain under the jurisdiction of the Board of Cemetery Trustees.

SECTION 2. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 3. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 4. That this Ordinance shall take effect and be in force after the earliest period allowed by law and Charter.
