**AN ORDINANCE**  
**NAMING THE ALLEY STARTING AT WEST WASHINGTON**  
**STREET AND ENDING AT CENTER STREET, BETWEEN**  
**WALNUT STREET AND WATER STREET AS HIMES WAY AND**  
**AMENDING THE TRAFFIC CONTROL MAP FOR THE**  
**VILLAGE OF CHAGRIN FALLS.**

WHEREAS, Benjamin Himes served the Village of Chagrin Falls in various capacities for approximately 40 years, starting out in the Utilities Department, gaining his engineer's degree while working full time for the Village and then serving as Chief Administrative Officer for the last 20 years of service to the Village ending in 2017; and

WHEREAS, Benjamin Himes has provided invaluable service and assistance to the residents of the Village and the Village Council has determined that in recognition of his service, designation of a public way named in Benjamin Himes' honor is fitting and appropriate; and

WHEREAS, the Village of Chagrin Falls wishes to express its gratitude and appreciation to Benjamin Himes for his dedicated service to the Village of Chagrin Falls by naming the alley that starts at West Washington Street and its terminus is at Center Street, which alley is located between Walnut Street and Water Street, as Himes Way.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, STATE OF OHIO:**

SECTION 1. That the public alley between Walnut Street and Water Street starting at its intersection with West Washington Street and has a southern terminus ending at the intersection of Center Street is hereby declared to be known as Himes Way.

SECTION 2. The Traffic Control Map and all official maps of the Village of Chagrin Falls shall be amended to designate such alley as Himes Way.

SECTION 3. That the Street Department for the Village of Chagrin Falls erect a street sign at the intersections of Himes Way with West Washington and Center Street designating the alley as Himes Way.

SECTION 4. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 5. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 6. That this Ordinance shall take effect and be in force after the earliest period allowed by law and Charter.
