A RESOLUTION AUTHORIZING THE VILLAGE ENGINEER TO PREPARE PLANS, SPECIFICATIONS, BID PROPOSALS AND A COST ESTIMATE FOR THE WALTERS ROAD UTILITIES AND ROADWAY REHABILITATION PROJECT.

WHEREAS, the Village Council has determined that Walters Road needs to be rehabilitated, and the utilities within the right-of-way need to be relocated; and

WHEREAS, this Council desires to authorize the Village Engineer to prepare plans, specifications, bid proposals and an estimate of the cost of the Walters Road utilities and roadway rehabilitation project, in order to determine whether Village Council should proceed with the construction of the Walters Road utilities and roadway rehabilitation project.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, CUYAHOGA COUNTY, AND STATE OF OHIO:

SECTION 1. That the Village Engineer is hereby authorized to prepare plans, specifications and bid proposals for the Walters Road utilities and roadway rehabilitation project, in order to obtain the information necessary to determine if the project should be constructed.


SECTION 2. The Village Engineer shall prepare a cost estimate for the Walters Road utilities and roadway rehabilitation project and submit it to Village Council for a determination of whether it should proceed with the construction of the project.

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 4. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Resolution shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 5. That this Resolution shall take effect and be in full force and effect upon the earliest date allowed by law.
