RESOLUTION NO. 2017 – 49 INTRODUCED BY: MS. LUTZ

A RESOLUTION AUTHORIZING THE VILLAGE ENGINEER TO PREPARE PLANS, SPECIFICATIONS AND BIDS FOR REPLACEMENT OF ONE HUNDRED AND FORTY (140) LINEAR FEET OF THE EASTERN MOST SECTION OF THE BRICK PATH AND STEPS IN RIVERSIDE PARK AND DECLARING AN EMERGENCY.

WHEREAS, over the years erosion and wear and tear has caused deterioration in the brick path and steps in Riverside Park commonly referred to as the library path ("Library Path"); and

WHEREAS, the Village has determined that one hundred and forty (140) linear feet of the eastern most section of the brick path and steps needs to be replaced; and

WHEREAS, this Council desires to authorize the Village Engineer to prepare plans, specifications and advertise for bids for the Library Path replacement of one hundred and forty (140) linear feet of the eastern most section of the brick path and steps in the Riverside Park ("Project").

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, CUYAHOGA COUNTY, AND STATE OF OHIO:

SECTION 1. That the Village Engineer is hereby authorized to prepare plans, specifications and then advertise for bids for the Project, in order to replace one hundred and forty (140) linear feet of the eastern most section of the brick path and steps in Riverside Park in order for the Library Path to continue to be used between the County library and the Riverside Park.

SECTION 2. The Village Engineer, in advertising bids, shall comply with all Village Ordinances and the Ohio Revised Code and submit his recommendation for the lowest and best bid to Village Council for approval and adoption of an Ordinance to authorize the Project to proceed.

**SECTION 3.** The Village Engineer is authorized to prepare, publish and circulate the plans and specifications in order to receive competitive bids in a timely manner.

SECTION 4. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

<u>SECTION 5</u>. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Resolution shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 6. This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of the inhabitants of the Village and for the further reason that this Resolution must be immediately effective so that the Village Engineer can proceed with plans, specifications and then advertise for bids to construct the Project in order to avoid further erosion and damage to the brick path and steps in Riverside Park and to allow for continued access between the library and Riverside Park; this Resolution shall be in full force and effect immediately upon its adoption by at least three-fourths (3/4) of the members of Council and approval by the Mayor.
