**A RESOLUTION AUTHORIZING THE MAYOR TO  
SUBMIT AN APPLICATION WITH THE OHIO  
DEPARTMENT OF NATURAL RESOURCES FOR  
FUNDING ASSISTANCE PURSUANT TO THE  
RECREATIONAL TRAIL PROGRAM AND  
DECLARING AN EMERGENCY.**

**WHEREAS**, the State of Ohio through the Ohio Department of Natural Resources, administers financial assistance for public recreation purposes, through the State of Ohio Recreational Trails grant program; and

**WHEREAS**, the Village desires financial assistance under the Recreational Trail Grant Program.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, CUYAHOGA COUNTY, AND STATE OF OHIO:**

**SECTION 1.** That the Village Council hereby approves the filing of an application for financial assistance from ODNR.

**SECTION 2.** That the Mayor is further authorized and directed to execute and file an application with the ODNR and to provide all information and documentation required to become eligible for possible funding assistance.

**SECTION 3.** That the Village does agree to obligate the funds required to satisfactorily complete the proposed project, including any required local match, and become eligible for reimbursement under the terms of the Recreational Trails Grant Program.

**SECTION 4.** That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

**SECTION 5.** That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Resolution shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 6. That this Resolution is declared to be an emergency measure for the immediate preservation of the public peace, property, health and safety of the inhabitants of the Village and for the further reason that the application submittal deadline to submit a grant is February 1, 2018, and the Village is in need of funding now for an eligible Recreational Trails Grant, and therefore this Resolution is needed to insure a timely application in order to be eligible for the ODNR Recreational Trails Grant Program, and providing this Resolution shall be in full force and effect from and after its adoption by two-thirds (2/3) of the Council and approval by the Mayor.




