RESOLUTION NO. 2020-22

INTRODUCED BY: Evans

A RESOLUTION

AUTHORIZING THE ENGINEER OF THE VILLAGE OF CHAGRIN FALLS TO PREPARE PLANS, SPECIFICATION BIDS AND ADVERTISE FOR REPAVING OF CERTAIN STREETS WITHIN THE VILLAGE AND FOR IMPROVEMENTS TO CURBS, SIDEWALKS AND THE ROADWAYS ON BELL STREET AND DECLARING AN EMERGENCY.

WHEREAS, the Village Engineer has determined that Bellview Street, Bradley Street, Maple Lane and Columbus Street should be repaved and certain sections of curb, sidewalk and road surface on Bell Street should be repaired or replaced ("Project");

WHEREAS, this Council desires to authorize the Village Engineer to prepare plans, specifications and advertise for bids for the Project;

WHEREAS, the Village Council has determined that the Project should be constructed in order to improve certain streets within the Village of Chagrin Falls.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, CUYAHOGA COUNTY, STATE OF OHIO

SECTION 1. The that Engineer for the Village of Chagrin Falls is hereby authorized to prepare plans, specifications and advertise for bids for the Project in order to repave Bellview Street, Bradley Street, Maple Lane and Columbus Street, and to perform repairs to certain sections of the curb, sidewalk, and repave the surface of Bell Street and to provide for spot repairs of curbs and sewers as needed based on plans and specifications prepared by CT Consultants, the Village Engineer.

SECTION 2. In advertising for bids, the Village Engineer shall comply with all the Village Ordinances and the Ohio Revised Code and the Village Engineer and the Chief Administrative Officer shall submit their recommendation for the lowest and best bid or bids to the Village Council for approval and for adoption of an Ordinance to authorize the Project to be constructed.

SECTION 3. The Village Engineer is authorized to prepare, publish and circulate the plans and specifications prepared by CT Consultants in order to receive competitive bids for the Project in a timely manner.

SECTION 4. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this

Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 5. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Resolution shall also be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 6. This this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health or safety of the inhabitants of the Village and for the further reason that this Resolution must be immediately effective so that bids can be timely received in order to construct the Project to improve certain roads within the Village at the earliest time possible and while weather permits; wherefore, provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Resolution shall be in full force and effect from and immediately upon its passage and approval by the Mayor, otherwise it shall take effect from and after the earliest period allowed by law.
