**A RESOLUTION
AUTHORIZING THE MAYOR OF THE VILLAGE OF
CHAGRIN FALLS TO ADVERTISE FOR BIDS FOR
PROJECTS IDENTIFIED IN THE 2021 CAPITAL PLAN
FOR THE VILLAGE OF CHAGRIN FALLS, AND
DECLARING AN EMERGENCY**

WHEREAS, the Village Council has determined that the Village should advertise for bids for certain projects (“Projects”) identified in the 2021 Capital Plan adopted by the Village Council (“Capital Plan”);

WHEREAS, the Village Council desires to authorize the Mayor to advertise for bids for such Projects, and where necessary, to have the Village Engineer prepare plans and specifications in order for meaningful bids to be received for the projects herein after identified;

WHEREAS, the Village Council has determined that bids should be received to determine which of the Projects should be approved for construction.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, CUYAHOGA COUNTY, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS ELECTED THERETO CONCURRING:

SECTION 1. The Mayor of the Village of Chagrin Falls is hereby authorized to advertise for bids for the Projects hereinafter set forth, and where necessary, to have the Village Engineer prepare plans and specifications, for the Projects:

- (a) 2021 Road Program
- (b) 2021 Sidewalk Repair Program
- (c) Arboretum Trail Project
- (d) Bell Street Storm Outfall Erosion Repair
- (e) Historic District Streets Utility Televising
- (f) Locust Lane Culvert Replacement
- (g) Riverside Park Walkway Replacement and Improvement
- (h) Summit-Cottage Storm Sewer Replacement
- (i) Triangle Park Sidewalk Replacement
- (j) Water Street Utility Improvements

SECTION 2. In advertising for bids, the Village Engineer and Mayor shall comply with all applicable Village Ordinances and the Ohio Revised Code and the Village Engineer and Mayor shall submit their recommendations for the lowest and best bid or bids to the Village Council for approval and adoption of an Ordinance to authorize any one or more of the Projects to be constructed.


SECTION 3. The Village Engineer is authorized, when directed by the Mayor, to prepare, publish and circulate the plans and specifications provided by CT Consultants, the Village Engineer, in order to receive competitive bids for the Projects in a timely manner.

SECTION 4. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 5. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Resolution shall also be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 6. That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health or safety of the inhabitants of the Village and for the further reason that this Resolution must immediately be effective so that bids can be timely received in order to construct the Projects, or portions thereof, at the earliest time possible and while weather permits and to avoid expected increases in the material costs; wherefore, provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Resolution shall be in full force and effect from and immediately upon its passage and approval by the Mayor, otherwise it shall take effect from and after the earliest period allowed by law.
