**AN ORDINANCE
AUTHORIZING THE MAYOR TO RENEW THE VILLAGE OF
CHAGRIN FALLS CONTRACT WITH DELTA DENTAL AND
DECLARING AN EMERGENCY.**

WHEREAS, the Village provides a dental plan to its employees and it is the recommendation of the Department of Finance that the Village renew its contract with Delta Dental, for a dental plan for Village employees effective July 1, 2017 through June 30, 2018, at a monthly premium rate for single coverage and for family coverage 4% lower than the rates in the existing policy; and

WHEREAS, the Village has determined to continue offering the non-compliant dental plan through June 30, 2018, by renewing the existing plan through June 30, 2018 (Dental Renewal Policy #0002027).

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, CUYAHOGA COUNTY, STATE OF OHIO:

SECTION 1. The Mayor is authorized to execute a renewal of the contract with Delta Dental (Dental Renewal Policy #0002027) for the provision of dental coverage for employees as set forth in said contract proposal for a term beginning July 1, 2017 and effective through June 30, 2018, and at the monthly premium rates set forth below:

Current Rates

Single = \$29.92

Family = \$88.24

Renewal Rates

Single = \$28.72

Family = \$84.71

SECTION 2. The Director of Finance is authorized and directed to appropriate to a proper account the funds necessary for the contract authorized in Section 1 of this Ordinance.


SECTION 3. The authorization of the contract by this Ordinance shall not be construed to prohibit the Village from deducting amounts to cover the premiums for coverage of Village employees from employees' compensation during the term of the contract authorized herein.

SECTION 4. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 5. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 6. That this Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of the inhabitants of the Village and for the further reason that the renewal of the plan needs to take effect beginning July 1, 2017 to continue to provide dental coverage for employees; wherefore provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Ordinance shall be in full force and effect from and immediately upon its passage by this Council and approval by the Mayor; otherwise, it shall take effect and be in force after the earliest period allowed by law.
