

**AN ORDINANCE**  
**AMENDING CODIFIED ORDINANCE SECTIONS 140.01 and**  
**140.02 TO ADD A RESIDENT TO THE PARKS COMMISSION**  
**AND ESTABLISHING THE TERM OF OFFICE.**

WHEREAS, the Council has determined that a fourth resident should be added to the Village Parks Commission; and

WHEREAS, Council has determined that the fourth resident member should serve for a term of three (3) years.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, STATE OF OHIO:**

SECTION 1. Codified Ordinance Section 140.01 shall be amended by amending the first sentence to read as follows:

There is hereby created a commission to be known and designated as the "Parks Commission", composed of four residents of the Municipality, and in addition one Council person.

SECTION 2. The existing first sentence of Codified Ordinance Section 140.01, the full text of which follows, is hereby repealed:

There is hereby created a commission to be known and designated as the "Parks Commission", composed of three residents of the Municipality, and one Council person.

SECTION 3. As amended, Section 140.01 of the Codified Ordinances, with strikeouts for deletions and underlining for additions, reads in its entirety as amended by this Ordinance as follows:

There is hereby created a commission to be known and designated as the "Parks Commission", composed of ~~three~~four residents of the Municipality, and in addition one Council person. Resident members shall be appointed by the Mayor, and Council shall appoint its representative.

SECTION 4. The first sentence of Codified Ordinance Section 140.02 shall be amended in its entirety to read as follows:

The term of the four resident members to be appointed shall be three years, with three of the four members' terms staggered based on appointments made prior to the effective date of this Ordinance.

SECTION 5. The existing first sentence of Codified Ordinance Section 140.02, the full text of which follows, is hereby repealed:

The term of the three resident members to be appointed shall be three years, provided that the term of one of the members appointed to the first Commission shall be for one year and one of the members appointed to the first Commission shall be for two years.

SECTION 6. As amended, Section 140.02 of the Codified Ordinances, with strikeouts for deletions and underlining for additions, reads in its entirety as amended by this Ordinance as follows:

The term of the ~~three~~four resident members to be appointed shall be three years, with three of the four members' terms staggered based on appointments made prior to the effective date of this Ordinance.~~provided that the term of one of the members appointed to the first Commission shall be for one year and one of the members appointed to the first Commission shall be for two years.~~ In the event that a vacancy occurs during the term of any member, his or her successor shall be appointed for the unexpired portion of the term.

SECTION 7. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 8. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 9. That this Ordinance shall take effect and be in force after the earliest period allowed by law and Charter.
