**AN ORDINANCE  
AMENDING APPENDIX A TO TITLE 1 of PART 3 OF  
THE CODIFIED ORDINANCES TO AMEND THE  
TRAFFIC CONTROL MAP PROVIDED FOR IN  
CODIFIED ORDINANCE SECTION 305.01 AND  
DECLARING AN EMERGENCY.**

WHEREAS, Codified Ordinance Section 305.01 established a Traffic Control Map to show at all times current traffic control matters and amendments may be made to the Traffic Control Map pursuant to Section 305.03 of the Codified Ordinances; and

WHEREAS, the Village Council has determined that the Traffic Control Map needs to be amended to add a stop sign at the intersection of Bell Street and Walters Road, as a result of improvements made to Walters Road.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE  
VILLAGE OF CHAGRIN FALLS, STATE OF OHIO:**

SECTION 1. Appendix A to Chapter 305 of the Codified Ordinances is hereby amended, in part, as follows:

- A. A stop sign shall be added at the intersection of Bell Street and Walters Road as depicted and specified on Exhibit "A" attached hereto and made a part hereof in the location shown thereon.

SECTION 2. As amended, Appendix A, with underlining for additions reads in its entirety as to those portions of the Traffic Control Map that are affected by this Ordinance as follows:

A. . Stop Sign.

Add a stop sign on Bell Street, for eastbound traffic at its intersection with Walters Road, to create a three way stop sign intersection.

SECTION 3. The Police Department is hereby directed to amend the Traffic Control Map accordingly, and to enforce parking in accordance with the Traffic Control Map, as

amended, from and after the effective date of this Ordinance. A copy of the Traffic Control Map, as so amended, shall be attached to and incorporated as part of the Traffic Code.

SECTION 4. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 5. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.


SECTION 7. That this Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of the inhabitants of the Village and for the further reason that due to improvement of Walters Road that are soon to be completed and the addition of a crosswalk on Walters Road, a stop sign is needed to protect pedestrians crossing Bell Street, since Bell Street eastbound traffic is not currently controlled by a stop sign; wherefore provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Ordinance shall be in full force and effect from and immediately upon its passage by this Council and approval by the Mayor; otherwise, it shall take effect and be in force after the earliest period allowed by law.


