

**A RESOLUTION  
DECLARING THE AMOUNT OF TAXES WHICH MAY  
BE RAISED WITHIN THE TEN MILL LIMITATION  
WILL BE INSUFFICIENT TO PROVIDE FOR THE  
NECESSARY REQUIREMENTS OF THE VILLAGE OF  
CHAGRIN FALLS, AND PROVIDING FOR THE  
SUBMISSION OF THE QUESTION OF THE RENEWAL  
OF AN EXISTING FIVE AND ONE-HALF MILL (5.50)  
TAX LEVY, IN EXCESS OF THE TEN MILL  
LIMITATION, FOR CURRENT OPERATING SERVICES,  
AT THE PRIMARY ELECTION TO BE HELD MAY 7,  
2019, AS AUTHORIZED BY OHIO REVISED CODE  
SECTIONS 5705.19 AND 5705.191, AND DECLARING AN  
EMERGENCY.**

WHEREAS, the electors of this Village on November 5, 2013, replaced a five and one-half (5.5) mill tax levy for current operating services for a period of five years, the last collection of which levy will occur in calendar year 2019; and

WHEREAS, this Council finds it necessary, in order to provide the Village with necessary funds for its operations and other current expenses, to renew said five and one-half (5.5) mill levy upon its expiration in accordance with Ohio Revised Code Sections 5705.19 and 5705.191; and

WHEREAS, on ~~January~~ 14, 2019, the Council enacted Resolution No. 2019-03 which, inter alia, requested the Cuyahoga County Fiscal Officer to certify the total current tax valuation of the Village and the dollar amount of revenue that would be generated by a renewal levy; and

WHEREAS, the Cuyahoga County Fiscal Officer has certified such information to the Village.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, CUYAHOGA COUNTY, STATE OF OHIO, TWO-THIRDS OF ALL THE MEMBERS ELECTED THERETO CONCURRING:**

**SECTION 1.** That it is hereby found, determined and declared that the amount of taxes which may be raised by the Village of Chagrin Falls within the ten-mill limitation and the rate authorized by Ohio Revised Code §5705.02 for the duplicate years 2019 through 2023 inclusive, will be insufficient to provide the necessary requirements of the Village of Chagrin Falls, and that it is necessary, for the purpose of providing additional funds for current operating expenses, to renew the

levy of a tax in the amount of five and one-half (5.50) mills for five (5) years in excess of such limitations and rate for such purposes.

**SECTION 2.** That the question of levying an additional tax, by a renewal of the existing levy, of five and one-half (5.50) mills outside the 10-mill limitation and in excess of the maximum rate authorized by Ohio Revised Code §5705.02 for the period of five (5) years, to-wit: on the 2019 through 2023 duplicate and lists, with distribution of the proceeds of the levy in the calendar years 2020 through 2024, inclusive, for current expenses, shall be submitted under the provisions of §§5705.19, 5705.191, 5705.25 and 5705.26, of the Ohio Revised Code and related sections, at a primary election to be held May 7, 2019, as authorized by law. Such election shall be held at the regular places of voting in the Village as established by the Board of Elections of Cuyahoga County, or otherwise, within the times provided by law and shall be conducted, canvassed and certified in the manner provided by law.

**SECTION 3.** That the form of the ballot to be cast at the election on the question of this tax levy shall be substantially as follows:

**PROPOSED TAX LEVY (RENEWAL)  
VILLAGE OF CHAGRIN FALLS**

A majority affirmative vote is necessary for passage.

A renewal of a tax for the benefit of the Village of Chagrin Falls for the purpose of current expenses at a rate not exceeding five and one-half (5.5) mills for each one dollar of valuation, which amounts to fifty-five cents for each one hundred dollars of valuation, for five years.

**SECTION 4.** That the Clerk of this Council be and is hereby authorized and directed to certify a copy of this Resolution to the Cuyahoga County Board of Elections on or before 4:00 p.m. on the ninetieth day before the May 7, 2019, election.

**SECTION 5.** That the Clerk of Council shall also submit to the Board of Elections of Cuyahoga County, Ohio a copy of the County Fiscal Officer's certification.

**SECTION 6.** That said Board of Elections and the Clerk of Council are hereby authorized and directed to cause a notice of such election to be published as provided by law.

SECTION 7. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 8. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Resolution shall also be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 9. That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health or safety of the inhabitants of the Village and for the further reason that preparations must be made in a timely fashion in order to have this matter placed on the ballot in May of 2019; wherefore, provided it receives two-thirds of the vote of all members of Council elected thereto, this resolution shall take effect and be in full force from and after its passage and approval by the Mayor, or otherwise it shall take effect from and after the earliest period allowed by law.


