**AN ORDINANCE
AMENDING SECTION 353.04 OF THE CODIFIED
ORDINANCES TO PROHIBIT PARKING FOR MORE
THAN THREE HOURS IN THE CENTRAL SHOPPING
DISTRICT BETWEEN THE HOURS OF 9AM to 6PM
DURING WEEKDAYS.**

WHEREAS, The Village Council has received complaints from Business Owners within the Central Shopping District that employees, business operators and others are parking cars within the Central Shopping District, in the same space, or moving the vehicle to another space within the Central Shopping District for more than three hours, taking away the limited resources of parking available within the Central Shopping District and therefore impairing the intent to preserve the Village's downtown core for retail sales and personal service businesses; and

WHEREAS, the Village has determined that in order to make parking spaces available for customers of businesses within the Central Shopping District it is necessary to limit parking within the Central Shopping District to a maximum of three hours, regardless of where the car is parked.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE
VILLAGE OF CHAGRIN FALLS, STATE OF OHIO:**

SECTION 1. Section 353.04 of the Codified Ordinances is hereby amended to add subsection (e) which reads in its entirety as follows:

(e) It shall be unlawful for the driver, or the person in charge of a vehicle, to park a vehicle within the Central Shopping District, as designated on the Zone Map of the Municipality of Chagrin Falls, as provided for in Section 1119.03 for more than three total hours in any nine hour span anywhere in the Central Shopping District between the hours of 9AM and 6PM during the weekdays of Monday through Friday, except that the provisions of this Section shall not apply to vehicles parked on the streets of the Village on declared holidays.

SECTION 2. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 3. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 4. That this Ordinance shall take effect and be in force after the earliest period allowed by law.


