**AN ORDINANCE
AMENDING THE RULES AND REGULATIONS FOR
CEMETERIES IN THE VILLAGE OF CHAGRIN FALLS,
AND AMENDING CODIFIED ORDINANCE SECTIONS
953.031 AND 953.07.**

WHEREAS, the Board of Cemetery Trustees has been eliminated by an amendment to the Charter of the Village of Chagrin Falls; and

WHEREAS, in Ordinance 2017-14, Section 953.04 of the Codified Ordinances was revised to provide that the Chief Administrative Officer is authorized to promulgate rules and regulations not inconsistent with the Charter and Codified Ordinances; and

WHEREAS, the Cemetery Commission has recommended that the rules, regulations, and procedures for use of Evergreen Hill Cemetery be amended and to increase fees and the Chief Administrative Officer has elected to implement the recommendations of the Cemetery Commission which requires amending Chapter 953 of the Codified Ordinances; and

WHEREAS, Council has determined that Sections 953.031 and 953.07 should be amended so that the rules and regulations that the Chief Administrative Officer proposes to be amended are not in conflict with the Codified Ordinances.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE
VILLAGE OF CHAGRIN FALLS, STATE OF OHIO:**

SECTION 1. Section 953.031(c) of the Codified Ordinances the full text of which follows is hereby repealed:

The sale of a niche to a non-resident will be considered on a case-by-case basis upon receipt of a written request.

SECTION 2. Section 953.031(f) of the Codified Ordinances is hereby amended to add the following language after the colon:

After 3:00PM on a weekday is \$500.00

SECTION 3. Section 953.031(g) of the Codified Ordinances is hereby amended in its entirety to read as follows:

The cost for a niche interment before 2:00PM Monday through Saturday is \$600.00 for residents and non-residents. The cost for a niche interment after 2:00 PM Monday through Saturday is \$850.00.

SECTION 4. Existing Section 953.031(g) of the Codified Ordinances the full text of which follows is hereby repealed:

The cost for a niche interment before 3:00PM on a weekday is \$400.00 and \$450.00 after 3:00PM and on a Saturday.

SECTION 5. As amended, Section 953.031(g) with strikeouts for deletions, and underlining for additions reads in its entirety as follows:

The cost for a niche interment before 2:00PM ~~3:00PM~~ Monday through Saturday ~~on a weekday~~ is \$600~~400.00~~ and \$450.00 ~~after for residents and non-residents, and on a Saturday weekday.~~ The cost for a niche interment after 2:00PM Monday through Saturday is \$850.00.

SECTION 6. Section 953.07(a) of the Codified Ordinances is hereby amended to read as follows:

SECTION 15. The Chief Administrative Officer of the Village is hereby authorized to revise the cemetery rules and regulations consistent with this Ordinance and Ordinance 2017-14 which shall be available for inspection and copying at the Office of the Chief Administrative Officer. The rules and regulations adopted by the Chief Administrative Officer of the Village may be amended from time to time and shall be enforceable in accordance with Section 953.09 and 953.99 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 16. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 17. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 18. That this Ordinance shall take effect and be in force after the earliest period allowed by law.




