

**AN ORDINANCE AUTHORIZING THE VILLAGE'S
PARTICIPATION IN THE OHIO DEPARTMENT OF
ADMINISTRATIVE SERVICES COOPERATIVE PURCHASING
PROGRAM FOR UNIFORM AND RUG SERVICES AND DECLARING
AN EMERGENCY.**

WHEREAS, Ohio Department of Administrative Services Cooperative Purchasing Program accepted a bid submitted in response to Bid No. RS900118 and Invitation to Bid No. RS900518 and the winning bidder is Cintas Corporation whom the Village had already been purchasing uniforms through in the past; and

WHEREAS, Cintas Corporation has presented the Village with a contract of acceptance of the State of Ohio Participation Agreement attached hereto and made a part hereof as Exhibit "A" which is referred to therein as Contract MLA #28462 ("Contract"); and

WHEREAS, this Council finds and determines it is appropriate for the Village of Chagrin Falls to enter into a contract with Cintas Corporation based upon the terms and conditions of the bid that was accepted by the Ohio Department of Administrative Services for uniform and rug services.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, CUYAHOGA COUNTY, STATE OF OHIO:

SECTION 1. That the Mayor is authorized to enter into the Contract attached hereto as Exhibit "A" with Cintas Corporation for the purchase, from time to time, until the Contract expires on July 31, 2022, of uniform and rug or mat services through the Ohio Department of Administrative Services Cooperative Purchasing Program, known as Contract No. RS900118, published as Index No. GDC020, based upon the terms and conditions set forth in the Invitations to Bid referenced above which were accepted by the State of Ohio Department of Administrative Services. Uniform and rug or mat purchases shall be made as needed, based upon the cost sheet provided by Cintas Corporation in response to Invitation to Bid No. RS900518, as accepted by the State of Ohio.

SECTION 2. Prior to making purchases through the program from Cintas Corporation, the Finance Director shall certify that sufficient funds are available for such purchases to be made. The terms and conditions set forth in Contract No. RS900118 are incorporated herein and made a part hereof by reference thereto based on Index No. GDC020 effective August 1, 2017 as published and republished, by the State of Ohio Department of Administrative Services, General Services Division, Office of Procurement Services.

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 4. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 5. That this Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health and safety of the inhabitants of the Village and for the further reason that this Ordinance must be immediately effective in order for the Village to be able to take advantage of lower rates available from Cintas Corporation for uniforms and rugs or mats and therefore immediate action is necessary to obtain such savings; wherefore provided it receives the affirmative vote of at least two-thirds (2/3) of all members elected to Council, this Ordinance shall be in full force and effect from and immediately upon its passage by this Council and approval by the Mayor; otherwise, it shall take effect and be in force after the earliest period allowed by law.
