

**AN EMERGENCY ORDINANCE
MAKING TEMPORARY APPROPRIATIONS FOR THE CURRENT
EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF
CHAGRIN FALLS DURING AND FOR THE YEAR ENDING DECEMBER
31, 2020.**

BE IT ORDAINED by the Council of the Village of Chagrin Falls, State of Ohio:

SECTION 1: That to provide for the current expenses and other expenditures of the Village of Chagrin Falls during and for the first three months of the year ending December 31, 2020, thereby and there is hereby appropriated from funds now in the treasury or estimated to come into the treasury during the said period from the collection of taxes levied for municipal purposes and from other sources of revenue, for the purpose and in the form hereinafter enumerated, to wit:

GENERAL FUND	\$2,200,000
STREET FUND	500,000
CAPITAL PROJECTS FUND	1,200,000
WATER FUND	800,000
SEWER FUND	700,000
WORKING EQUIPMENT FUND	<u>300,000</u>
GRAND TOTAL	\$ 5,700,000

SECTION 2. That all expenditures of the Village of Chagrin Falls within the period ending March 31, 2020, shall be made within and with the appropriation herein before provided.

SECTION 3. That the Director of Finance is hereby authorized and directed to draw warrants on the Village depository for any portion of the amounts within the above named appropriation whenever claims are presented, properly approved by the head of the department for which the indebtedness is incurred.

SECTION 4. It is hereby found and determined that all formal actions of Council concerning and related to the passage of this Ordinance were adopted in a lawful meetings of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 5. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 6. That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, or safety of the inhabitants of the Village, in that the ordinance will provide the means for payment of salaries,

wages, and other vital obligations of the Village for its continued and uninterrupted operation, and provided it receives two-thirds vote of all members of Council elected thereto, this Ordinance shall take effect and be in full force from and after its passage and approval by the Mayor, or otherwise from and after the earliest period allowed by law.
