

AN ORDINANCE  
AUTHORIZING THE CLERK TO ADVERTISE FOR BIDS FOR VARIOUS  
MATERIALS, SUPPLIES, REPAIRS, AND CONSTRUCTION FOR THE YEAR  
2020

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, STATE OF  
OHIO:

Section 1. That the Clerk be and he is hereby authorized to advertise for bids for the following materials, supplies, repairs, and construction to be used by various departments of the Village during the year 2020, except as otherwise noted:

Gasoline, lubricating and fuel oil, and salt.

Road Program, Sidewalk Program, hot and cold premixed bituminous street patching and surfacing materials, asphalt, sand mix blacktop, and street sweeping.

Working Equipment for use by various Village departments, maintenance service on E911 equipment, and uniforms/Police Department.

Chemicals such as chlorine, sodium aluminate, polymers and poly-phosphate. Laboratory work for water and Wastewater Treatment Plant.

Cast iron ductile pipe, copper tubing, hydrants, valves and other appurtenances, pumps, meters and meter repair parts.

Illuminated traffic signals and appurtenances, traffic signs and appurtenances, street name signs and appurtenances.

Trees and other materials (including labor) for planting, tree stump removal, and tree trimming and landscaping.

Electrical, plumbing, heating, and other general building repairs to various Village buildings. Custodial service.

Waste disposal, service of radio equipment, maintenance of traffic signals, traffic and street marking, trenching, excavation and cemetery openings, insurance (for various periods), maintenance of parking meters, ambulance service.

Said bids to be in accordance with specifications to be filed in the office of the Clerk; and that the Mayor and Director of Finance be and they are hereby authorized to enter into contracts with the lowest and best bidders upon approval of the Village Council.

Section 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in lawful meetings of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

Section 3. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.


