

**ORDINANCE NO. 2020-47

**AN ORDINANCE
REQUESTING THE COUNTY FISCAL OFFICER TO ADVANCE TAXES FROM
THE PROCEEDS OF THE 2020 TAX LEVIES PURSUANT TO OHIO REVISED
CODE SECTION 321.34 AND DECLARING AN EMERGENCY.**

**BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS,
STATE OF OHIO:**

Section 1. That the County Fiscal Officer is hereby authorized and directed to turn over to the Director of Finance of the Village of Chagrin Falls, Ohio, all monies now in the hands and that may hereafter come into the hands of the County Treasurer which are payable to the Village of Chagrin Falls from the proceeds of the 2020 tax levies and other collections during 2021, as soon as practicable after the Fiscal Officer receives said monies.

Section 2. That the Director of Finance is hereby authorized to furnish a copy of this Ordinance to the County Fiscal Officer and County Treasurer.

Section 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Legislation were adopted in an lawful meetings of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

Section 4. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Ordinance shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

Section 5. That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health or safety of the inhabitants of the Village, in that the ordinance will establish such necessity by reason of the fact that all monies due and owing the Village of Chagrin Falls must be deposited in the Village treasury as soon as possible to assure the best possible use of the assets of the community, and provided it receives two-thirds vote of all members of Council elected thereto, this Ordinance shall take effect and be in full force from and after its passage and approval by the Mayor, or otherwise from and after the earliest period allowed by law.
