**A RESOLUTION
REQUESTING CUYAHOGA COUNTY TO PROCEED WITH
THE REHABILITATION OF NORTH MAIN STREET
BRIDGE 00.12 LOCATED IN THE VILLAGE OF CHAGRIN
FALLS RESOLVING TO PAY ONE HUNDRED PERCENT
(100%) OF THE CONSTRUCTION COST FOR
DECORATIVE LED LUMINAIRES TO REPLACE THE
EXISTING LUMINAIRES PRIOR TO THE RE-
INSTALLATION OF THE EXISTING LIGHT POLES ON
THE BRIDGE AND DECLARING AN EMERGENCY.**

WHEREAS, rehabilitation of North Main Street Bridge 00.12 located in the Village of Chagrin Falls is being financed by Cuyahoga County and Federal funds; and

WHEREAS, the Agreement between Cuyahoga County and the Village of Chagrin Falls states that if the COUNTY is formally requested by a MUNICIPAL RESOLUTION to include the construction of sanitary sewers, waterlines, area sewers (drainage of area surrounding the improvement), sidewalks, alternate bid items, or other items in the improvement that are in addition to those now existing and not provided for elsewhere in the Agreement, the COUNTY will do so, provided that this construction meets with the approval of the COUNTY and the MUNICIPALITY involved in this improvement; and that the MUNICIPALITY agrees to pay, or make arrangements for the payment of, the cost of said additional construction, the cost of preliminary and design engineering, and construction supervision.

WHEREAS, by this resolution, Cuyahoga County is formally requested to include the decorative LED luminaires, which are not provided for elsewhere and are a replacement of or a repair to that which now exists.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF CHAGRIN FALLS, CUYAHOGA COUNTY, STATE OF OHIO:

SECTION 1. That Cuyahoga County is hereby requested to include decorative LED luminaires on light poles to be reinstalled, which are not provided for elsewhere and are a replacement of and/or a repair to that which now exists, in the plans and specifications for the rehabilitation of North Main Street Bridge 00.12 located in the Village of Chagrin Falls; and

SECTION 2. The Village of Chagrin Falls agrees to assume one hundred percent (100%) of the construction costs of any expenses incurred by Cuyahoga County for the items specified, in the subject improvement; and

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 4. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Resolution shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 5. That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health or safety of the inhabitants of the Village and for the further reason that in order for plans for the rehabilitation of North Main Street Bridge 00.12 located in the Village of Chagrin Falls to be timely approved by Cuyahoga County and said project timely bid, so that the decorative LED luminaires can be included in the project; wherefore, provided it receives two-thirds of the vote of all members of Council elected thereto, this resolution shall take effect and be in full force from and after its passage and approval by the Mayor, or otherwise it shall take from and after the earliest period allowed by law.


