

**RESOLUTION NO. 2020 – 3

**A RESOLUTION CREATING A COUNCIL COMMITTEE
ON COMMUNICATIONS FOR THE YEAR 2020 TO
INVESTIGATE AND RECOMMEND TO COUNCIL AND
ADMINISTRATION WAYS TO IMPROVE VILLAGE
COMMUNICATIONS, AND DECLARING AN
EMERGENCY**

WHEREAS, the tools of communication have changed substantially in the last decade;
and

WHEREAS, the Village website has software components that are no longer supported;
and

WHEREAS, social media integrates into any Village communication strategy to ensure compliance with public records and open meeting laws.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE
VILLAGE OF CHAGRIN FALLS, CUYAHOGA COUNTY, AND STATE OF OHIO:**

SECTION 1. The Council hereby creates a Communications Committee of Council to function during the calendar year 2020 to investigate and recommend to Council and the Village Administration ways to improve Village communications.

SECTION 2. The Communications Committee shall review and recommend the best course of action to update the Village website, improve emergency notification systems and increase participation by the Village residents and businesses in enhanced communications, to consider a newsletter to be sent to residents and businesses in the Village and recommend a social media policy to be implemented by the Village for use by employees and appointed and elected officials of the Village.

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 114 of the Codified Ordinances of the Village of Chagrin Falls.

SECTION 4. That in accordance with Section 113.01 of the Codified Ordinances of the Village of Chagrin Falls, public notice of this Resolution shall be given by posting a copy thereof for not less than fifteen (15) days in the Village Hall.

SECTION 5. That this Resolution is hereby declared an emergency measure immediately necessary for the preservation of the public peace, health and safety of the

inhabitants of the Village and for the further reason that in order to timely improve and enhance communications of Village Ordinances, policies, emergencies, and to encourage the fullest amount of participation by the residents and businesses in the Village, so that Communications Committee recommendations can be implemented; wherefore, provided it receives two-thirds (2/3) of the votes of all members of Council elected thereto, this Resolution shall take effect and be in full force from and after its passage and approval by the Mayor, otherwise it shall take effect from and after the earliest period allowed by law.
